02. Last date for receipt of completed registration form: 30 October 2009.
03. The organiser will make all efforts to allot space as required by the applicant on a first come first served basis. However, the organisers reserve the right of allotment and their decision in this regard shall be final.
04. The stall allotted is non-transferable. The participants shall not sublet the space to any third party and shall not use the space allotted for any other purpose other than for which it is meant.
05. Any tax liability arising out of this exhibition, in respect of any stall, any article exhibited therein, any commodity sold or to be sold from there or any other matter in respect of the exhibition by any concerned authority shall be borne by the respective allottees.
06. No refund will be given for cancellations after the closing date of registration.
07. In case the allottees would like to have any special arrangements, including extra power and light connections, they should inform the office at least two days before and such facilities can be arranged by us. The expenses will have to be borne by the concerned allottees.
08. Any commercial liability and all dealings thereof shall entirely be the responsibility of the participants.
09. Participants should ensure that their banners, name boards and other display materials do not project outside their respective stall passages etc. They should also ensure that their sound systems, if any, do not cause disturbance to neighbouring stalls or in general prove to be a nuisance. Besides, participants shall take all precautions to exhibit their wares in a dignified and presentable manner.
10. Participants shall take all steps to protect their stall exhibits during exhibition hours, while the organisers will make arrangements for over all security in the exhibition complex. They will not be responsible for any damage or theft of property or injury to persons caused by fire, acts of nature or any reason beyond our control.
